Assessing Firm Beginning Annual Visits to Properties

The assessing firm of Commerford Nieder Perkins LLC is beginning their annual review of properties in New Hampton. They will be visiting properties to re-measure and re-list assessment data, requesting access to the interior whenever possible to be sure properties are accurately listed. They will carry photo identification with them and will leave yellow tags on doors to notify residents they have visited their property. These visits are required by the NH Dept. of Revenue to ensure all properties within the town and the state are being fairly assessed.

Dan Ward (2012 Grey Ford Fusion – Plate #3626602) and **John Hatfield** (2006 Blue Ford Explorer – Plate #1529373) will be performing the visits during the month of December and possibly some of January.

MEETING AT: 8:30 A.M., at the New Hampton Public Safety Building, 26 Intervale Drive located at the junction of NH Routes 132 South and 104, west of I-93, exit 23. Look for a black Toyota Tacoma Pickup with NEFCo signs. Timber will be shown rain or shine!

Only one showing of the timber will be made, but a prospective buyer may obtain a private showing by paying for the Forester's time and travel expenses (office to office).

Property of Town of New Hampton, Managed by Conservation Commission:
Located on Kelley Pond Road. Tax Map R-4, Lot 49. Timber to be sold is marked in blue paint.

TOTAL FOREST AREA TO BE CUT: (60 acres) . LOGGING CHANCE: Good.
Individual tree volumes are based on local tables that take into account: diameter, merchantable length, and average taper.
Softwood is figured to a merchantable top diameter of 8 inches; hardwood, 10 inches.
