2016 Tax Rate Has Been Set and is Down from 2015

On November 17th, the Department of Revenue issued the New Hampton Tax Rate. The Tax Rate is being reduced from \$18.19/per 1000 to \$17.99/per 1000. The tax bills have been mailed and are due by Friday, December 30, 2016.

As of 11/1/2016 you are now able to make on-line tax payments if you wish or search for tax bill information. Go to the Towns website at:

1. Select TAX COLLECTOR ONLINE SERVICES

2. Select "Property Taxes" icon

3. Enter e-mail address

4. Type in Map & Parcel # (if not sure click on sample invoice on how to add as it has to be exact.)

5. If not sure of what your parcel # is – select the "Search for MAP/PARCEL #" box to the right and you will be able to search by owner's name or by address.

6. You can also print a "PDF" statement and will also be able to look at the history of payments.

7. We still do not take debit or credit cards, but you can pay your bill by using your checking account by entering the routing # and account #.
