LOCAL POLICE DEPARTMENTS WORK WITH DEA FOR THE COLLECTION OF UNUSED, EXPIRED AND UNWANTED PRESCRIPTION DRUGS

**NEW HAMPTON PUBLIC SAFETY BUILDING
24 INTERVALE DRIVE, NEW HAMPTON**

Saturday, April 28, 2012 from 10am to 2pm

This spring, the Drug Enforcement Administration (DEA) and its national and community partners will give the public another opportunity to prevent pill abuse and theft by ridding their homes of potentially dangerous expired, unused, and unwanted prescription drugs.

On Saturday, April 28th, from 10 a.m. to 2 p.m., DEA and its partners will hold their second National Prescription Drug Take-Back Day at sites nationwide. During this timeframe any pharmaceutical (prescription or over-the-counter) drug may be dropped off at the locations listed below. The service is free and anonymous—no questions asked. All efforts will be made to protect the anonymity of those disposing of the medications and no requests for identification will be made by police. Intravenous solutions, injectables, syringes and aerosol inhalers will not be accepted. Once collected, the drugs will then be turned over to the DEA and destroyed.

DOG LICENSES/REGISTRATIONS

All Dogs must be licensed through the Town by April 30th. If a dog is not licensed by June 1st, there will be a forfeit of \$25.00 and a fine of \$1.00 per month.

License Fees are:

Male or Female	\$9.00
Spayed or Neutered	\$6.50
Puppies – 3 months to 7 months	\$6.50
Dog for owner over Age 65	\$2.00 (one dog only)

CURRENT rabies certificate must be presented at time of registration, if not already on file. Residents are reminded that it is unlawful for any dog to run at large unless accompanied by and under the control of the owner or custodian.
